This cookie policy has been created to comply with [Law 34/2002 of 11 July, on Information Society Services and Electronic Commerce \(LSSICE\)](#), and with the various guides published by the competent control authorities on the subject.

The legal obligations imposed by the regulations are twofold, the obligation to:

1. transparency that Spain Startup complies with by informing by means of this cookies policy and
2. the obligation to obtain consent via the pop-up banner that popped up when you first accessed <http://www.southsummit.co>.

2.- DEFINITION AND GENERIC FUNCTION OF COOKIES

2.1.-What are cookies?

Cookies are small files that websites, online shops, intranets, online platforms or similar, store in the browser of the user who visits them and are necessary to provide web browsing with countless advantages in the provision of interactive services. In general, these technologies can be used for a wide range of purposes, such as, for example, recognising you as a user, obtaining information about your browsing habits, or personalising the way in which content is displayed. The specific uses that Spain Startup and Investor Services S.L. makes of these technologies are described in point 3.

2.2.-Types of cookies according to the length of time they remain active

Depending on the length of time they remain activated in the terminal equipment, we can distinguish:

- a. **Session cookies:** These are usually used to store information that is only of interest for the provision of the service requested by the user on a single occasion. These are temporary cookies designed to collect and store information while the user accesses a web page.
- b. **Persistent cookies:** Privacy risks could be reduced by the use of session cookies. These are those in which the data remains stored in the terminal and can be accessed and processed for a nest period of time by the party responsible for the cookie, which can range from a few minutes to several years.

2.3.-Types of cookies according to the entity that manages them

Depending on the entity that manages the equipment or domain from which the cookies are sent and processes the data obtained, we can distinguish:

- a. **First-party or own cookies:** these are those that are sent to the user's terminal equipment from a computer or domain managed by the owner/editor of the Website and from which the service requested by the user is provided.
- b. **Third-party cookies:** these are those that are sent to the user's terminal equipment from a computer or domain that is not managed by the owner/editor of the Website, but by another entity that processes the information obtained through the cookies.

In the event that the cookies are installed from a computer or domain managed by the owner/editor of the Website, but the information collected through them is managed by a third party, they will also be considered third-party cookies.

2.4.-Types of cookies according to their purpose

There are many ways in which cookies can be used. Depending on the purpose for which the data obtained through cookies is processed, some of the modalities may be:

- a. **Technical purposes:** are those that allow the user to navigate through a website, platform or application and the use of the different options or services that exist in it, including those that the editor uses to allow the management and operation of the website and enable its functions and services, such as, for example, control the processing and communication of data, identify the session, access parts of restricted access, remember the elements that make up an order, carry out the process of purchasing an order, manage payment, control fraud linked to the security of the service, make an application for registration or participation in an event, count visits for the purposes of billing licenses of the software with which the service operates (website), manage payment, control fraud linked to the security of the service, make the application for registration or participation in an event, count visits for the purposes of billing licenses for the software with which the service (website, platform or application) operates, use security features during browsing, store content for the broadcasting of videos or sound, enable dynamic content (for example, animation of loading text or images) or share content through social networks.
- b. **Personalisation:** these are cookies that allow information to be remembered so that the user can access the service with certain characteristics that may differentiate their experience from that of other users, such as, for example, the language, the number of results to be displayed when the user performs a search, the appearance or content of the service depending on the type of browser through which the user accesses the service or the region from which they access the service, etc. If these features (e.g. language) are chosen by the user himself, the cookies are exempted from the obligations of [Article 22.2 of the LSSI](#) as it is considered a service expressly requested by the user, provided that the cookies are exclusively for the purpose selected.
- c. **Analysis or performance:** these are those that allow the person in charge of them to monitor and analyse the behaviour of users of the websites to which they are linked, including quantifying the impact of advertisements. The information collected through this type of cookie is used to measure the activity of the website, application or platform, in order to make improvements based on the analysis of the data on the use made by users of the service.
- d. **Behavioural advertising:** these are those that store information on user behaviour obtained through the continuous observation of their browsing habits, which allows the development of a specific per I to display advertising based on the same.

2.5.-Cookies exempted from complying with the regulations

It should be noted that cookies used for any of the following purposes are exempt from compliance with the obligations established in article 22.2 of the LSSI:

- Only allow communication between the user's equipment and the network.
- Strictly to provide a service expressly requested by the user.

In this sense, the WG29, in its [Opinion 4/201211](#), interpreted that among the exempted cookies would be those that are intended for nality:

- a. **"User input" cookies** (*Session and user input cookies are typically used to track user actions when filling in online forms on various pages, or as a shopping basket to keep track of items the user has selected by clicking a button*).
- b. User authentication or identification cookies (session only).
- c. User security cookies (*e.g. cookies used to detect repeated, erroneous attempts to log on to a website*).
- d. Media player session cookies.
- e. Session cookies for load balancing.
- f. User interface customisation cookies.
- g. Certain plug-in cookies to exchange social content (*the exception only applies to users who have chosen to keep their session open*).

Therefore, it can be understood that these cookies are excluded from the scope of application of article 22.2 of the LSSI, and, therefore, it would not be necessary to inform or obtain consent for their use.
